# PRIVACY POLICY OF THE WWW.berlindancecamp.COM WEB SERVICE

### 1. General information

1.1. The web service operating at www.berlindancecamp.com here in after referred to as: "The Web Service", is run by Wenzel & Boateng GbR with its registered office at: Herbststr. 33, 13409 Berlin, Tax Identification Number): 17/586/00834

#### 2. Personal data

- 2.1. The Web Service uses forms that allow the clients of the Web Service, hereinafter referred to as: "Clients", to order a chosen ticket package. The data contained in the form are not shared with third parties other than with the consent of the Client, unless otherwise specified below. In connection with the operation of the Web Service, the following personal data of the Clients is collected:
- 2.1.1. first and last name.
- 2.1.2. gender
- 2.1.3. e-mail address,
- 2.1.4. telephone number,
- 2.1.5. first and last name of parent / guardian
- 2.1.6. country,
- 2.1.7. date of birth,
- 2.2. Providing such data is voluntary but necessary to use the services offered by the Web Service. The Web Service can, with the consent of the Client, use the information listed above to send information about the status of the order, products, services, offers and the possibility to receive the newsletter. If the information mentioned above are transmitted electronically, they will be sent only if the Client has agreed to receive them in this form.
- 2.3. The administrators of personal data within the meaning of the Act of 29 August 1997 on the protection of personal data (unified text: Journal of Laws of 2002, No. 101, item 926, as amended) collected in the context of the Web Service is: Wenzel & Boateng Gbr. with its registered office at: Herbststr. 33, 13409 Berlin, Tax Identification Number):

The Clients have the right to obtain information about their personal data collected by the Web Service, the right to correct and erase their data and right to demand their data to no longer be used. ## 3. Cookies

- 3.1. The Web Service does not collect any data in an automated manner, except for the data contained in cookies during the use of the aforementioned website. Cookie files are small files stored on the Client's end device. They are necessary for the proper use of the Web Service. Typically, cookies contain the name of the website from which they come, the time for which they will be stored on end devices and a unique number.
- 3.2. Cookies used by the Web Service can be temporary or permanent. Temporary cookies are deleted when you close your browser while permanent cookies are stored even after the Client ceases to use the website.
- 3.3. Cookies used by the Web Service may be necessary for the proper functioning of the Web Service. Cookies belonging to this category are used to, among others: maintain user sessions, save the state of the user's session, enable authorization.
- 3.4. The Web Service also uses cookies which are not necessary for the use the Web Service but facilitate its use. They are used to:
- 3.4.1. allow for the restoration of a recently visited screen when the user uses the Web Service next time,
- 3.4.2. remember the user's choice regarding not displaying selected messages or displaying them for a selected number of times,
- 3.4.3. restore the user's session, check whether the saving of cookies functions properly,
- 3.4.4. enable automatic log in, match the content of products to the preferences of the Web Service's user,

- 3.4.5. set the preferred language, currency and other such features to facilitate the use of the Web Service.
- 3.4.6. restore the last search result in the Web Service.
- 3.5. The Web Service uses the services of third parties that use cookies to:
- 3.5.1. monitor traffic in the Web Service.
- 3.5.2. collect anonymous, aggregated statistics that allow the owner of the Web Service to understand how users use the Web Service and to continuously improve the products,
- 3.5.3. determine the number of anonymous users of the Web Service,
- 3.5.4. determine how often selected content is shown to the users,
- 3.5.5. determine how often users choose a given service,
- 3.5.6. examine newsletter sign ups,
- 3.5.7. use a system of personalized recommendations for e-commerce,
- 3.5.8. operate communication tools,
- 3.5.9. integrate with social networks,
- 3.6. At any time the Client has the ability to change cookies settings by defining the conditions of their storage and the conditions for the Client's device to be accessed by cookies. Such changes can be made via the web browser settings or by using service configuration. Changes to the cookies settings can consist of, among others, blocking the installation of cookies and removing permanent cookies by using appropriate options in the web browser used by the Client. Rejecting cookies may mean that some features offered by the Web Service may not work properly or, in some cases, that a given feature may be completely unavailable.

# 4. Server logs

- 4.1. Information about some of the Clients' behaviors are subject to logging into the server layer. These data are used only to administer the Web Application and to ensure efficient customer service.
- 4.2. Viewed resources are identified by their URLs. The following data may be stored: order or query arrival time, response time, the URL of the website previously visited by the Client when the Web Service was visited via a hyperlink, information about the Client's browser, information about the IP address. The data indicated above is not associated with specific people who use the Web Service.

## 5. Other provisions

- 5.1. We reserve the right to disclose selected information concerning the Client or another individual who uses the Web Service to the competent authorities or to third parties which submit a request for such information based on an appropriate legal basis in accordance with applicable law.
- 5.2. Links allowing Clients to directly reach other websites may be placed in the Web Service. The Web Service does not affect the privacy policy or cookies policy adopted by the administrators of these websites, and does not assume any responsibility for them.
